17. DIRECTIONS TO THE SITE

The project is located on the western side of Coral Harbor, approximately 1,000' south of the terminus of King Hill Road.

18. Nature of Activity (Description of project, include all features)

This project consists of construction of fixed docks as shown in the attached documentation to accommodate up to 145 vessels of varying length. Most of the vessels are expected to be transient, occupying a slip for a limited period of time. There is no dredging associated with this project. Dock construction will consist primarily of 15-inch coated-steel piles tied together with precast concrete pile caps supporting a grated decking to allow light penetration to the seabed below. Mooring piles will be either 12-inch or 15-inch diameter. Access to the marina will be via a single controlled walkway to the fixed docks. A public dinghy dock will be located midway between the shoreline and the first slip at the marina. This 20-foot by 40-foot dinghy dock will provide a safe docking area and allow ample public access to utilize adjacent businesses in the Coral Bay area. The Zone 1 docks will be a total of about 21,100 square feet (ft²), Zone 2 will be about 40,800 ft² and the main walkway will be a total of about 12,900 ft². There is an existing rip-rap revetment along the southern shoreline of the property, some minor repair may be required. Seventy-five (75) moorings will be installed with Helix anchoring systems. 19. Project Purpose (Describe the reason or purpose of the project, see instructions)

The purpose of this project is to construct a marina with 145 slips of varying dimension. The project will also provide 12 moorings associated with the marina and will manage 75 moorings throughout Coral Harbor as a public private partnership with DPNR.

The marina has been positioned so that all dredging can be avoided. The docks have been located to avoid the scattered coral heads found with in the shallows. The project will be directly impacting approximately 2500 sq. ft.(0.06 acres) due to the placement of 1333 piles ranging from 12-17" in diameters. Due to wave turbulence seagrass will also be lost surrounding the piles. The dock itself occupies 1.42 acres of which 181 sq. ft. (0.004 acres)will be over areas with seagrass and coral rubble, 1567 sq. ft. (0.013 acres) over area of sparse seagrass, 41,546.37 sq. ft. (0.95 acres) over areas with 30%-100% seagrass coverage , 27,072 sq. ft. (0.62 acres)(continued)

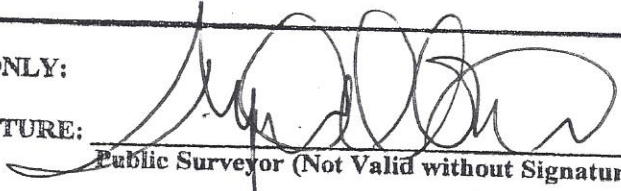

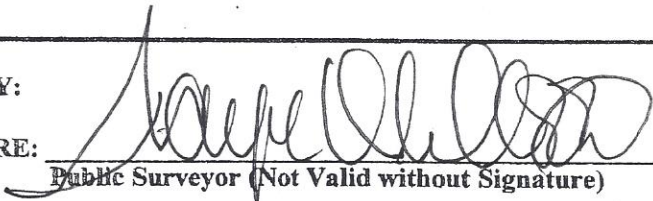

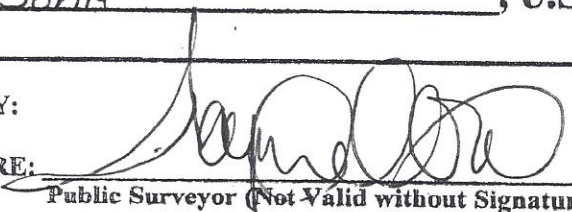
